



LIST OF RECOMMENDATIONS AND LIMITATIONS

Below you will find a list of limitations and recommendations to keep in mind when preparing your shoot. This list will be updated periodically.

We recommend that you take them into account not only on requesting the occupation permits but also when selecting your filming locations.

What is currently a recommendation may become a limitation if the impact is not minimized.

Complying with these recommendations and limitations does not mean that your requests will be automatically approved; as you know, each request is assessed individually and many more factors are considered.

PUBLIC STREETS:

The whole city:

It is recommended to bring **the minimum number of vehicles** necessary and to adapt this according to the district. If we continue to receive excessive parking needs, restrictive measures will be implemented and the number of vehicles will be limited.

If you have a **large fleet** (big trailers, caravans, etc.), we recommend hiring alternative Base Camps ([Forum](#), [Sot del Migdia](#), [Port Vell](#)...).

Traffic closures must be scheduled on weekends or public holidays. If filming on these days is not possible, we recommend setting up closures on secondary roads and avoiding rush hours and school start/end times.

Please note that vehicles and generators **cannot be parked on sidewalks**, in any district.

Ciutat Vella:

It is recommended to minimize the **number of vehicles**.

Space reservations for technical vehicle parking are not authorised in the **Green or Residents zones**.

Impact on **DUM zones** (loading/unloading) must be minimized – both in time and space.

If filming over several days, **written notice** must be provided to local residents and businesses.

Parking on **c/ Ferran is not authorized** outside of loading/unloading hours (Mon-Sat 8-11 am and 3-5 pm).

Example:

Parking space reservation for technical vehicles in **DUM zones (loading/unloading) during working hours is not authorized**.

Space reservation for camera movements in **DUM Zones during working hours is not authorized**.

Parking space reservation for technical vehicles is **not authorized** on the green axis of c/ Consell de Cent or on its cross streets (pedestrian or not).

Avoid filming near the intersection of **C/ Consell de Cent and C/ Girona**.

Avoid reserving space for technical vehicles in **motorbike zones**, especially on weekdays (including Saturday). Give priority to Blue and Green Zones. Parking in motorbike areas will be assessed case by case.

Technical vehicles may not all park together: up to 4 (including the generator) can be near the location, and the rest must be parked in other streets in groups of up to 3.

Sants-Montjuïc:

No authorizations will be given for filming on **Montjuïc Mountain and surrounding areas** on weekends or public holidays.

No filming is authorized on **Montjuïc Mountain and surrounding areas** on F.C. Barcelona match days at the Estadi Olímpic Lluís Companys.

Avoid filming or parking near **Plaça Espanya, Av. Maria Cristina, and Av. Rius i Taulet** (fairground areas).

Avoid filming or parking near **Plaça Espanya and its connecting roads** (Gran Via, Av. Paral·lel, c/ Tarragona) during L8 metro line works.

Avoid reserving parking in DUM zones during working hours; prioritize Blue and Green Zones.

Les Corts:



Space reservation for technical vehicle parking in DUM zones during working hours is **not authorized**.

Sarria-Sant Gervasi:

Parking or filming is **not authorized** on c/ Tuset and nearby streets (c/ Moià, c/ Granada Penedès, and nearby areas of Travesera de Gràcia and c/ Aribau).

Authorizations for c/ Comte Salvatierra (both for filming and parking) will be limited. A few months must pass between uses. Check the date of the last authorization.

Parking space reservation for technical vehicles in DUM zones during working hours is **not authorized**.

No parking or filming authorization in **Plaça Frederic Soler** and surrounding areas.

Gracia:

Avoid reserving parking in DUM zones during working hours. Prioritize Blue and Green Zones.

Minimize the number of vehicles.

No circulation or parking of vehicles or generators in **public squares** is authorized.

Horta-Guinardo:

Filming at the Carmel Bunkers is not authorized except for small-scale, historically themed productions with prior District approval.

Filming at the **Carmel petanque** area is not authorized.

Minimize parking reservations in the **Green Zone**.

Sant Andreu:

Occupation for filming in **Plaça Masadas** is **not authorized**.

Sant Martí:

Parking space reservations for technical vehicles in **DUM or motorbike zones during working hours are not authorized**.

Camera movement reservations in **DUM or motorbike zones during working hours are not authorized**.

Traffic closures on **weekdays** are **not authorized**.

Occupations on **Pg. Garcia i Faria** on weekdays are **not authorized**.

No occupation, parking, or materials on sidewalks on **c/ Perú**.

No reservations for parking or camera movements on **c/ Tànger**, between c/ Roc Boronat and Rbla. Poblenou (both sides), on weekdays.

No parking or filming is authorized inside the “**superilla**” area (bounded by c/ Tànger – c/ Badajoz – c/ Pallars – c/ Llacuna, including both sides of these streets).

Other recommendations:

Signpost the reservations of space to park as indicated in the **protocol** (8 days in advance). It is best if you can process the permits in advance of these 8 days in order to have the file number of each permit to put on the notices (as indicated in the protocol).

PARKS AND GARDENS:

In the most visited parks (**Parc del Laberint**, **Parc de la Ciutadella**, and parks located on **Montjuïc Mountain**), filming permits will **not** be granted on **weekends or public holidays**.

In other parks and gardens, we also recommend avoiding occupation on weekends and holidays whenever possible.

Parking inside parks and gardens is not allowed. Access is only permitted for loading and unloading purposes, and only on designated paths.

Filming in **Park Güell** is not authorized unless it has a **scientific or educational purpose** related to the park's heritage.

Jardines de Elisava square, previously public space, must now be processed under the **Parks and Gardens** category.

Filming and photo shoots are not authorized in the following parts of the breakwaters:
