

LIST OF RECOMMENDATIONS AND LIMITATIONS

Below you will find a list of limitations and recommendations to take into account to prepare your shoot. This list will be periodically updated.

We recommend that you take them into account not only on requesting the occupation permits but also on choosing your locations.

What now appears as a recommendation may become a limitation if the level of impacts is not minimized. Complying with these recommendations and limitations does not mean that your requests are automatically authorized; as you know, each request is assessed individually and many more aspects are taken into account.

PUBLIC STREETS:

The whole city:

You are recommended to bring **the smallest number of vehicles** possible and to adapt this to the district in question. If we continue to receive excessive parking requests, restrictive measures will begin to be applied and the number of vehicles will be limited.

If you have a **large amount of vehicles** (big trailers, caravans, etc.), we recommend hiring alternative Base Camps (<u>Forum, Sot del Migdia, Port Vell.</u>..).

Traffic interruptions must take place at weekends or on bank holidays. If it is not possible to shoot on these dates, we recommend interrupting the traffic on secondary roads and avoiding the rush hour and school start and finish times. And we also remember that **you cannot park vehicles or generators on the sidewalk**, in any district.

Ciutat Vella:

We recommend minimizing the number of vehicles.

Reserving space to park technical vehicles in Green Area or Residents Area is not permitted.

Whenever the communication concerns several days, you will have to notify residents and shops of the impact in writing.

Eixample:

Reserving space to park technical vehicles in **DUM Area (Loading and Unloading) is not permitted during working hours**. Reserving space for camera shots in **DUM Area is not permitted during working hours**.

Reserving space to park technical vehicles in the Green Axis of Carrer Consell de Cent or in the streets which intersect it (whether or not pedestrian) is not permitted.

We recommend avoiding shooting in the area of the intersection between Carrer Consell de Cent and Carrer Girona.

We recommend avoiding reserving space to park technical vehicles in **motorbike parking areas**; you should prioritize the Blue Area and Green Area.

Sants-Montjuïc:

Impacts are not authorized on Montjuïc Mountain and the surrounding area on weekends or bank holidays.

Impacts are not authorized on Montjuïc Mountain and the surrounding area on days of F.C. Barcelona matches in the Lluís Companys Olympic Stadium.

We recommend not shooting or parking in the area around the exhibition sites of Plaça Espanya, Avinguda Maria Cristina and Avinguda Rius i Taulet.

We recommend not shooting or parking in the area around **Plaça Espanya and connections close to** Gran Via, Avinguda Paral·lel, Carrer Tarragona during the building work on L8.

We recommend not requesting a reservation of space to park in **DUM Area** during working hours; the Blue Area and Green Area must be prioritized.

Les Corts:

Reserving space to park technical vehicles in DUM Area is not permitted during working hours.



Sarria-Sant Gervasi:

Reserving space to park technical vehicles or occupation of space to film in **Carrer Tuset and the surrounding area** (Carrer Moia, Carrer Granada Penedès, and areas close to Travesera Gracia and Carrer Aribau) is not permitted.

Authorizations in **Carrer Comte Salvatierra** (both to shoot and to park) will be limited. A few months must be left between different impacts. Consult the date of the last impact.

Reserving space to park technical vehicles in **DUM Area is not permitted during working hours**.

Gracia:

We recommend not requesting the reservation of space to park in **DUM Area** during working hours; you should prioritize the Blue Area and Green Area.

We recommend minimizing the number of vehicles.

It is not permitted to drive or position vehicles or generators in the squares.

Horta-Guinardo:

It is not permitted to film in the **Carmel bunkers**, except for small historical-type productions with prior authorization from the district

It is not permitted to film in the Carmel pétanque.

We recommend minimizing the reservation of parking in Green Area.

Sant Martí:

Reserving space to park technical vehicles in **DUM Area or motorbike parking area** during working hours is not permitted. Reserving space for camera shots in **DUM Area or motorbike parking area** during working hours is not permitted.

Traffic interruptions on working days are not permitted.

The occupation of space on Passeig Garcia i Faria on working days is not permitted.

The occupation of space in **Carrer Perú**, or parking, shooting, or positioning material on the pavement, is not permitted. Reserving parking space (to park technical vehicles or for camera shots) in **c/ Tànger between c/ Roc Boronat and Rbla. Poblenou**, both sides, during working hours is not permitted.

Other recommendations:

Signpost the reservations of space to park as indicated in the **protocol** (8 days in advance). It is best if you can process the permits in advance of these 8 days in order to have the file number of each permit to put on the notices (as indicated in the protocol).

If we are handling the permit at the BFC, we will provide you with this number.

PARKS AND GARDENS:

Permits are not authorized at the **weekend or on bank holidays** in the most visited parks (Parc del Laberint, Parc de la Ciutadella and parks located on Montjuïc Mountain).

In the rest of the parks and gardens we recommend also avoiding occupation during the **weekend and on bank holidays** whenever possible.

You cannot park inside parks and gardens; you can only access them with vehicles to carry out loading and unloading tasks (always using the paths established).

Filming is not permitted in Parc Güell which does not have a scientific or educational purpose linked to its heritage.

The Plaça dels Jardins d'Elisava must be arranged as a Park.
